### **DATE OF ELECTION AND ADVANCE POLLING**

Advance Polling: Sunday, December 22, 2024 from 11:00 am - 3:00 pm

Sunday, December 29, 2024 from 12:00 pm - 4:00 pm Wednesday, January 8, 2025 from 6:00 pm - 9:00 pm

Election Day: Sunday, January 12, 2025 from 10:45 am - 3:00 pm

Members will have another opportunity to hear each candidate speak again on the morning of Election Day, January 12, 2025, at 9:30 am. Voting will commence immediately after the candidate's speeches.

The right to vote is restricted to members who are in good standing for at least one (1) year, in accordance with the Constitution and By-Laws.

A list of members in good standing and able to vote is posted in the Front Office of the Club. Each member in good standing should ensure that his/her name is on the voters list. If your name is not on the voters list at the time of balloting, you will not be allowed to vote unless you have written confirmation from the Treasurer of the Club that you are a member in good standing in accordance with the Constitution and By-Laws of the Club and your name has been inadvertently omitted from the voters list.

There will be no proxy or absentee balloting of any kind permitted.

### **VOTING PROCESS**

Every person who is entitled to vote will receive a ballot, of which the back of the ballot has been duly validated in accordance with the Constitution and By-Laws of the Club.

The voter shall proceed to one of the voting compartments and there mark the ballot following the name(s) of the candidate(s) he/she intends to vote for.

The voter shall return the ballot to the Election Committee member who shall examine the proper validation and then place the ballot in the ballot box in the presence of the voter.

The voter shall vote without undue delay and shall leave the polling place as soon as his/her ballot has been placed in the ballot box.

Every person wishing to vote must identify himself/herself and if required must produce proper evidence of identity.

A person who has received a ballot shall not take it out of the election place and a person who receives a ballot and leaves the election place without delivering it to a member of the Election Committee, or return same declining to vote, forfeits his/her right to vote.

A voter who has inadvertently handled the ballot in such a manner it cannot be conveniently used, upon returning it to a member of the Election Committee, is entitled to another ballot and the returned ballot will be marked "cancelled".

# Ballots will be rejected if:

- a) The ballot has not been supplied and validated by the Chief Election Officer;
- b) the ballot has been marked improperly;
- c) there is any writing or mark by which the voter can be identified.

Please note that the Election Committee will try to make the election process as efficient as possible; however, your cooperation will be required to achieve this end.
